

SUMMER READING SWEEPSTAKES
OFFICIAL RULES
Pritzker Military Museum & Library

NO PURCHASE REQUIRED TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. . The Summer Reading Sweepstakes (the “**Sweepstakes**”), is sponsored by Pritzker Military Museum & Library (the “**Sponsor**”).

ELIGIBILITY: Open only to legal residents of the fifty (50) United States and the District of Columbia who are PMML members in good standing and 13 years of age or older at time of entry. Eligible Entrants who are under the legal age of majority in their state of primary residence (a “Minor”) must get their parent or legal guardian’s permission to participate in the Sweepstakes. A Minor Entrant will be required to provide parental consent in a form satisfactory to the Sponsor before they can be declared a winner and any prize can be awarded under the terms of these Official Rules. Any entries not eligible for any reason will be disqualified from winning the prize. Employees of Sponsor, and its parent, affiliates, subsidiaries, and advertising and promotion agencies involved in this Sweepstakes, and their immediate family members (parent, child, spouse, sibling and their respective spouses, regardless of where they reside) and/or those living in the same household of each, whether or not related, are not eligible to participate in or win the Sweepstakes. Void where prohibited by law. All applicable federal, state and local laws apply.

HOW TO ENTER: Entry does not require a payment or a purchase of any kind. Beginning 12:00 a.m. C.T. on July 15, 2022 through 11:59:59pm C.T. on September 5, 2022 (the "Entry Period"), (i) complete reading a book available from the Pritzker Military Museum and Library (“PMML”); and (ii) fill out the entry form located at URL or available at the PMML and submit in the ballot box, for one (1) entry into the Sweepstakes. In order to enter the Sweepstakes, you must be a member of PMML with a valid account. Entries must be received by 11:59:59pm PST on September 5, 2022 or close of business at the PMML. Limit one (1) entry per unique email address and per person per completed book, during the Entry Period. Multiple entries received from any unique email address after the first entry with respect to each book, will be void. Proof of transmission is not proof of receipt. Entries generated by script, macro or other automated means are void, as are entries that are illegible, garbled, incomplete or that contain errors. Normal time, toll, connection and usage rates, if any, charged by your Internet service provider will apply. All entries become the property of the Sponsor. No other entry method will be accepted.

RANDOM DRAWING/WINNER NOTIFICATION/ VALIDATION: Two (2) Winners will be selected in a random drawing on or about September 20, 2022 (the “Draw Date”) from among all eligible entries received during the Entry Period by Sponsor, whose decisions are final and binding with respect to all matters related to the Sweepstakes. Potential Winner(s) will be notified by email and/or mail. Potential Winner (or if potential winner is a minor, their parent or legal guardian) may be required to execute and return an Affidavit of Eligibility/Release of Liability/Publicity (where legal) form within seven (7) days of the date attempted notification is sent. Noncompliance within this time period, with these Official Rules or the return of any prize/prize notification may result in disqualification and, at Sponsor’s discretion, an alternate potential winner may be selected by random drawing from among all remaining eligible entrants. Prizes will be fulfilled approximately 2-3 weeks after winner validation. Any winner later determined to be ineligible may be required to return his/her prize. Any taxes on prize are the responsibility of the winner.

One (1) winner will receive “Prize 1” comprised of (i) a PMML Baseball Hat (ARV \$20), (ii) Lest We Forget t-shirt (ARV \$5), (iii) *In the Lake of the Woods* (book ARV \$14.95), (iv) *The Things They Carried* (book ARV \$24), and (v) a Tote and Commemorative Key Chain (ARV \$10) (total ARV of Prize 1 is \$73.95); and One (1) Winner will receive “Prize 2” comprised of (i) *Cold War Neon* book (ARV \$55), (ii) a Lest We Forget t-shirt (ARV \$5), (iii) 4 military rubber ducks (\$11.96), (iv) a PMML Baseball Hat (ARV \$20), (v) a WWII clicker (ARV \$9), a (vi) Paper hat, (vii) War on Error erasers (ARV \$5), (viii) Soldiers Action Stickers (ARV \$4), and (ix) a We Can Do It Posters from World War II cards for kids to color (total ARV of Prize 2 is \$109.96);. All prize details are at the sole discretion of the Sponsor. No substitution or transfer of prize except in Sponsor’s sole discretion; if any advertised prize becomes unavailable, Sponsor may award a substitute of comparable value. Odds of winning will depend upon the number of eligible entries received.

NO WARRANTIES: Sponsor makes no warranties covering any of the prizes furnished as part of this Sweepstakes. Any prize, and all materials furnished as part of or in connection with this Sweepstakes are provided "as is" without warranty of any kind, either express or implied, including without limitation the implied warranties of merchantability or fitness for a particular purpose.

PRIVACY: Sponsor may receive email addresses, personally identifiable information and other data concerning Sweepstakes participants when they enter the Sweepstakes. Winner's name and contact information will be used in order to contact winner for the purpose of fulfillment of prizes. Any information supplied by entrants will be used in accordance with Sponsor's Terms of Use and Privacy Policy.

Sponsor reserves the right in its sole discretion, to cancel, suspend or modify the Sweepstakes, or to disqualify any implicated entrant(s), (and their entries) if any fraud, virus, actions by entrants, technical or other error or problem, or any other occurrence corrupts or affects the administration, integrity, security, or proper play of the Sweepstakes, as determined by Sponsor in its sole discretion. In the event of cancellation, Sponsor reserves the right, at its sole discretion, to award the prize in a random drawing from among all eligible, non-suspect Entries received up to the time of the event or action warranting such cancellation.
